Minutes of a Meeting of the Llandow Community Council held at Llandow Village Hall, Llandow,

**105/14. PRESENT:** Mr. C. Cornelius (Chairman), Mr. M. Hurst (Vice Chairman), Mr. A. Clarke, Mr. T. Phillips, Mr. R. Crandon, Mrs. A. Pattinson, Ms. J. Shaw, County Borough Councillor R. Thomas and Mr. D-L. Jones (Clerk).

**106/14. APOLOGIES:** Mr. S. Murton and PCSO C. Griffiths.

**107/14. DECLARATIONS OF PECUNIARY INTEREST, ETC:**

There were no declarations of interest made.

**108/14. POLICE REPORT:** PCSO C. Griffiths reported by email that there had been no incidents of crime reported in the Llandow ward during the preceding month.

**109/14. MINUTES OF THE MEETING OF THE 6<sup>th</sup> NOVEMBER 2014:**

**101 /14.** Cllr. R. Thomas reported that he is still waiting for a response from the VGCBC in regard of 30mph speed limits signs been installed at Sigingstone.

**101/14** Cllr. R. Thomas reported that he is still waiting for a response from Mr. P. Beamen in regard of the tree which is damaging the wall at the cross roads in Sigingstone.

**d) Approval of the Precept 2015 / 2016**

Council unanimously agreed, on the proposal of Cllr. M. Hurst, seconded by Cllr. T. Phillips to set a Precept of £6,800 for the forthcoming financial year.

**112/14. C.A.S.H. GRANT SCHEME:**

Cllr. M. Hurst reported that he had spoken with the Officer at the VGCBC and the CASH Grant Scheme has been exhausted for this financial year. The Officer did not know if there would be a funding for the scheme 2015/16. We await an update in due course.

**113/14. REPRESENTATIVES REPORTS:** Cllr. M. Hurst reported that he had attended an extraordinary meeting of the Community Liaison Committee in regard of the devolution of services from the VGCBC to Town & Community Councils – grass cutting, public lavatories, etc. Cllr. Hurst had pointed out that the administration, costs, liability and responsibility of a Community Council like Llandow providing such services would be onerous and would inevitably mean a very large increase in the Precept. The Council Officers present could not provide an idea as to the costs of the services or a timescale for their transfer (if at all). We await further information in due course.

Cllr. A. Pattinson reported that she had received an email (previously circulated) from Roger Prescott in regard of the community consultation undertaken by S & A about their proposed expansion at Llandow. Council noted the contents of the email. We await a planning application in due course.

**117/14. LLYSWORNEY:** Cllr. M. Hurst reported that S&A Brains had refused to allow the Polling Station to be placed on their car park, however Mr. Chris Ball has given permission for it to be located at Llysworney garage.

**118/14. SIGINGSTONE:** Cllrs. A. Clarke and C. Cornelius reported the road from the centre of Sigingstone to Llanmihangel is now in need of complete resurfacing. The Clerk will report this matter to the VGCBC.

The Clerk reported that he had received an email in regard of the refurbishment of the Air Crash Memorial. Cllr. R. Thomas agreed to enquire of the VGCBC if they are responsible for the memorial's maintenance. The Clerk will respond accordingly.
