- 68/13. APOLOGIES:** PCSO S. Thomas, Mr. H. Walters and Mr. M. Hurst (Vice Chairman).
- 69/13. DECLARATIONS OF PECUNIARY INTEREST, ETC:**

- 70/13. POLICE REPORT:**
The Clerk reported that he had received a report by email from PCSO S. Thomas in which he stated that there had been one crime in the ward during the past month which had been the theft of fencing panels from Llandow Industrial Estate.
- 71/13. MINUTES OF THE MEETING OF THE 4th APRIL 2013:**
The Minutes of the last meeting, having been circulated, were accepted as a true record.

- 72/13. MATTERS ARISING:**
- 28/13: Springfield Spray:** Cllr. T. Phillips reported that he had failed to make contact with the new owner.
- 42/13: Access Road to Llandow Civic Amenity Site:** Cllr R. Thomas reported that the VGCBC have been in touch with the new managing agents of the Business Park, HRT, and discussions are underway to get the road upgraded with the support of Harris Pye Ltd who would like to gain access from the bottom end of the site.
- 44/13: Resurfacing of Grove Road:** Cllr. R. Thomas reported that he has been unable to ascertain a timescale from the VGCBC of when the resurfacing work at Grove Road is to be undertaken but he has been assured that it will be completed within this financial year.
- 45/13: Trees at Llysworney:** Cllr S. Murton reported that the necessary work has been done to the trees.
- 45/13 Speed warning Sign at Llysworney:** Cllr R. Thomas reported that the VGCBC do not have the funds to install such signs.
- 46/13 Lane from Sigingstone to Llanmihangel:** Cllr. C. Cornelius reported that no work had been undertaken to repair this stretch of road which is in imminent danger of becoming impassable to motor vehicles. Furthermore, that kerbstones, which had fallen into the brook have now been dumped on the grass verge which is not only unsightly but also dangerous.
