46/13 Lane from Sigingstone to Llanmihangel: Cllr. C. Cornelius reported that no work had been undertaken to repair this stretch of road which is in imminent danger of becoming impassable to motor vehicles. The Clerk will ask VGCBC for an update.

114/13. LLANDOW: Cllr. T. Phillips reported several potholes throughout the village and gave the Clerk a list of their locations. The Clerk will report the location of the potholes to the VGCBC.

Cllr. T. Phillips reported that the drain outside Great House Farm is still blocked. The Clerk will report this to the VGCBC.

Cllr. T. Phillips reported that he is hopeful that Network Rail will clean out the culverts in Llandow during September / October.

115/13. LLYSWORNEY: Cllr. M. Hurst reported (by email) that the verges at the Cross Inn need to be cut back as they are affecting the vision splay. The Clerk will report this to the VGCBC.

Cllr. M. Hurst reported (by email) that one of the pieces playground equipment has been removed from Llysworney Play Area but no replacement has been installed. The Clerk will ask for an update from the VGCBC.

Cllr. S. Murton reported that there are a number of potholes between Crossways and the Cross Inn. The Clerk will report this to the VGCBC.

116/13. SIGINGSTONE: Cllr. A. Clarke reported that there are a number of potholes on the road to Llanmihangel. The Clerk will report this to the VGCBC.

Cllr. A. Clarke reported that he had been asked by Sigingstone Community Association if the Community Council would pay for a skip for the September village 'clean up'. This was duly approved.

117/13. COUNCIL DECISIONS: There were no Council Decisions to report.

118/13. OTHER BUSINESS: The Clerk reported that it would soon be obligatory for all Town & Community Councils to have a website, a grant of £500 being available from the Welsh Government to facilitate this. The Clerk had received a quotation of £500(inc VAT) from YesNo Ltd for the creation of a website and 'hosting' of it for one year. Council agreed that this seemed a very reasonable price and asked the Clerk to proceed with this.
