#### 165/13. POLICE REPORT:

PCSO S. Thomas reported that no further progress had been made in detecting the perpetrators of the two crimes which he had reported at the last meeting: the theft of horse riding equipment from stables at Llandow and the theft from Llandow Race Circuit of approximately £2000 worth of kit which belonged to someone who was visiting the track for the day.

PCSO S. Thomas reported that investigations are being made into the cause of both fires at the Site Serve warehouse at Llandow.

## 166/13. MINUTES OF THE MEETING OF THE 7th NOVEMBER 2013:

The Minutes of the last meeting, having been circulated, were accepted as a true record. Proposed by Cllr. M. Hurst, seconded by Cllr. J. Shaw.

## 167/13. MATTERS ARISING:

114/13 Network Rail Culverts: Cllr. T. Phillips reported that Network Rail had undertaken some work to clear the drainage system to the South of the Village which had caused even more water to enter the brook that runs through the village and which had in turn caused some minor flooding. Network Rail had also cleared the entrance to the blocked/collapsed culvert which was of no benefit whatsoever in alleviating the problem. However, a manger from Network Rail had attended during the flooding, so had seen first-hand what the problems are. He had agreed that the obvious solution was to drive a 'large bore' culvert through the embankment, thereby by allowing flood water to dissipate more readily and hopefully avoiding flooding. We await with interest progress in this matter.

115/13 Llysworney Play Equipment: Cllr. M. Hurst reported that he had made some enquiries with the Llysworney Community Association in regard of funding a new piece of play equipment and also replacing the safety flooring in the play area. Cllr Hurst will now begin the process of applying for grants to finance this scheme.

**174/13 Scots Pine near Llysworney Church:** The Clerk has received no response from the VGCBC in this matter so will email them again in regard of the same.

It was agreed that the Clerk would send letters, which Cllr. Hurst had drafted, to the VGCBC Planning Dept stating clearly Councils objection to the potential loss of such an important community assets and also to Brains Brewery Ltd asking for an update of progress in this matter. Cllr. S. Murton reported that he had been in communication with a former resident of Llysworney who wishes to

place a memorial bench near the pond in the village. It was agreed to support this and it was suggested that a good location would be on the grass verge against the wall of 'the Chestnuts'.
