Minutes of a Meeting of the Llandow Community Council held at the Llandow Sigingstone Village Hall, Sigingstone, on Thursday 1st September, 2016 at 7.30 pm

114/16. PRESENT: Mr. C. Cornelius (Chairman), Mr. M. Hurst (Vice Chairman), Mrs. A. Pattinson, Mr. S. Murton, Mr. A. Clarke, Mr. T. Phillips and Mr. D-L. Jones (Clerk).

Cllr. T. Phillips reported that there is not an unsuitable for HGV sign at the Ewenny end of the road to Llandow. The Clerk will report this to the VGCBC.

Cllr. A. Pattinson reported that whilst several pot holes have been filled the entrance to the village near Maes y Felin is in desperate need of complete resurfacing. The Clerk will report this to the VGCBC.

Cllr. A. Pattinson reported that soft plastics are not taken for recycling at the Llandow Civic Amenity Site, only hard plastics. The Clerk will report this to the VGCBC.

124/16. LLYSWORNEY: Cllrs. S. Murton and M. Hurst reported that the new refuse collection system seems to be very disorganised with several phone calls having to have been made to the VGCBC to get all waste and recycling collected.

Cllr. M. Hurst reported that Slatters Lane is falling into disrepair, whilst it is not a through Road and is generally only used by agricultural vehicles the current surface is a health and safety risk to pedestrians. The Clerk will report this to the VGCBC.

BT Broad Band: Cllr. C. The meeting is to discuss the current extremely poor level of broadband in the rural Vale and what can be done to improve this vital service. Hurst will also submit some questions in writing.
