93/20. DECLARATIONS OF PECUNIARY INTEREST, ETC:

Cllr. A. Clarke declared a pecuniary interest in all matters concerning the preplanning consultation for land to the south west of Sigingstone.

94/20. MINUTES OF THE PREVIOUS MEETINGS:

It was agreed to accept the minutes of the meeting held on 5th November 2020, proposed by Cllr. C. Cornelius seconded by Cllr. J. Shaw.

95/20. POLICE REPORT:

PCSO A. Stone conveyed (by email) that one crime had been reported in the preceding month: Theft of a coal bunker – Llandow / Sigingstone

PCSO A. Stone reminded Council that if anyone is interested in Rural Watch she would be happy to drop off an information pack.

PCSO A. Stone wished the members of the Council a safe Christmas and New Year.

96/20. MATTERS ARISING:

Darren Farm Development, Weight Limit through Llysworney, Traffic Calming at Penyrheol Terrace & Re-alignment of Nash junction: The Chairman reported that She. Cllr. J. Shaw. Cllr. C. Cave and the Clerk would be attending a meeting with the VGCBC the following week to discuss the installation of signage and other related issues. Cllr. P. Bryant asked if the contractual obligation of Taylor Wimpey in this matter could be ascertained.

Nash Junction: Cllr. C. Cornelius reported that notices have appeared on the lampposts at Nash Junction. He had not been able to stop to see what they are for. Other Members agreed to investigate this further.

50/20 Milestone: Cllr. P. Bryant confirmed that Chris at Llysworney Garage has the milestone. It requires some minor repair which he will undertake before re-instating the milestone at its original location.

85/20 Flooding & drainage issues: Cllr. A. Pattinson apologised to Cllr. C. Cave for the misunderstanding regrading the meetings that had taken place so far. Cllr. Pattinson agreed to keep Cllr. Cave in loop should she want to attend future meetings.

Cllr. A. Pattinson reported that a second meeting had taken place between residents of properties at Llandow affected by flooding, Cllrs. C. Bray, J. Shaw, herself and the Clerk had attended. Reports were made about various issues. Cllr. Pattinson had been in touch with Welsh Water and an engineer had explained in some detail how the Llandow system worked and the problems caused by an ageing system with increasing demand and rain fall levels. Residents gave their specific findings. After discussion it was agreed to set up a resident's action group to take this matter forward which would work with the Community Council. Mrs. K. Walters agreed to be the 'point of contact' to gather information prior to communication with the various agencies concerned about their specific obligations.

It was unanimously agreed on the proposition of Cllr. C. Bray, seconded by Cllr. C. Cornelius to make a grant of £150.00 to each community to cover core costs/loss of income due to the Covid 19 pandemic. The grants would be made to Llandow and Sigingstone Village Halls and Llysworney Community Association.

102/20. PLANNING:

Maes y Fro, Llysworney: Cllr. J. Shaw reported that the landowner was continuing to use the property for purpose that are not permitted, and buildings have been erected without planning permission. The Clerk had reported this matter to the planning authority.

103/20. LLANDOW:

Accident near Splot Cross: Cllr. R. Thomas reported (by email) that an accident had occurred the previous Friday. It was serious the Fire Brigade were in attendance to release someone from a car. This crossroads is very dangerous when turning from Llandow, especially towards Wick, as vision left and right is very limited. Hedges cut right back would help, especially towards Llantwit Major. Also, the Council have erected a sign blocking vision from high vehicles, lorries and tractors, on the Llantwit Major side. This is a very fast road and there have been many accidents, fortunately no deaths at this junction. The council have installed 'slow' road markings on the approach in both directions on B4267. Please could they send a highway engineer out to survey and improve this junction. It was agreed the Clerk would write to the VGCBC about this matter.
