39/19. DECLARATIONS OF PECUNIARY INTEREST, ETC:

No declarations of interest were made.

40/19. MINUTES OF THE PREVIOUS MEETINGS:

It was agreed to accept the minutes of the meeting of the 6^{th} June 2019.

41/19. POLICE REPORT:

PCSO Stone conveyed (by email) that there had been no crimes reported during the previous month.

42/19. MATTERS ARISING:

Darren Farm Development & Weight Limit through Llysworney: The Clerk confirmed that he had written to Ms. C. Pugh and Mr. M. Clogg, VGCBC asking for an update on the current position but had not received a response as yet.

It was reported that the local Police Inspector had met with the Llysworney Action Group. Whilst the official view of South Wales Police is not to support the application for a weight restriction due to resource/capacity issues with enforcing them, it was the Inspector's view that such a restriction was desirable on this road. Furthermore, he confirmed that the VGCBC do not need the support of the police to make the order for a weight restriction. We await further information in due course.

Cllr. J. Shaw reported that a planning application 2014/01505/8/CD for road signage and off-site road proposals was available on the VGCBC's website. Cllr. Shaw had been in touch with the case officer and is awaiting a response to several queries.

It was noted with some disappointment that Council have not been kept up-to-date with progress in this matter having requested, and been assured, of the same.

Changes in waste collection: Four members had attended the presentation at Ewenny Village Hall regarding the new waste collection system that is being rolled out across the VGCBC. All agreed it had been a worthwhile evening.

Grass Cutting: It was reported that the standard of grass cutting is appalling with Members having reported several areas which had not been cut at all, or when they had been, looked a complete mess. Cllr. Cave is aware of the problem and has also complained. There is quite clearly very little supervision of the contractors.

Cllr. A. Cave suggested that Council might consider undertaking the work themselves. Several Members commented that this had been discussed previously, but owing to the considerable costs that would inevitably be generated by the letting of a contract and the attendant costs of supervision, insurance, etc it was felt that this was something Council did not wish to do at this juncture.

Llandow Recycling Centre: Colin Smith (VGCBC) had confirmed that enquiries are ongoing to find a suitable location for a new site for the recycling centre in the Western Vale.
