Minutes of a Meeting of the Llandow Community Council held at Llandow Village Hall, Llandow on Thursday 5th September 2019 at 7.30 pm.

55/19. PRESENT: Mr. C. Cornelius (Chairman), Mr. R. Thomas (Vice Chairman), Mr. P. Bryant, Mr. A. Clarke, Mrs. A. Pattinson, Ms. J. Shaw, Mr. R. Finucane, Ms. A. Newman and Mr. D-L. Jones (Clerk).

The Chairman welcomed Ms. A. Newman to the meeting, (see item 71/19. below).

- 56/19. APOLOGIES: Mrs. C. Bray, Mr. A. Cave, County Borough Councillor C. Cave and PCSO A. Stone.
- 57/19. DECLARATIONS OF PECUNIARY INTEREST, ETC:

No declarations of interest were made.

58/19. MINUTES OF THE PREVIOUS MEETINGS:

It was agreed to accept the minutes of the meeting of the 4th July 2019. Proposed by Cllr. A. Pattinson, seconded by Cllr. R. Thomas.

59/19. POLICE REPORT:

PCSO Stone conveyed (by email) that the following crimes had been reported in the preceding months: July: Burglary at Llandow Industrial Estate and damage to a vehicle at Llandow Industrial Estate. August: Theft of Garden Items from the Llandow area and malicious communications at Llysworney.

60/19. MATTERS ARISING:

Darren Farm Development & Weight Limit through Llysworney: The Clerk reported that a response had been received from Mr. Clogg. This confirmed that the VGCBC would not be restricting the weight of traffic through Llysworney from the Nash Manor junction to Pentre Meyrick or changing the alignment of the junction at Nash Manor. Cllr. J. Shaw had drafted a letter to the Managing Director of the VGCBC setting out Council's objections to this and seeking an urgent meeting to discuss the matter. After some discussion it was unanimously agreed to send the letter – see Appendix 1.

Collection of food waste: Cllr. A. Pattinson reported that difficulties had been experienced with the collection of food waste in the previous two months. Cllr. Pattinson and several Llandow residents had independently reported the instances of non-collection to the VGCBC and it transpired that each person had been given a different reason for the problem. Other Members confirmed they had experienced the same problems in their areas. It is hoped that these issues will be resolved once the new waste collection systems have had a chance to bed in.

Grass Cutting: It was reported that the standard of grass cutting seems to have improved as the contractor has settled into a regular routine.

Cllr. A. Pattinson reported that following complaints on 'Llandow Hub' regarding the children's play area in the village, she had contacted the Parks Dept at the VGCBC. Wyndam Hughes had arranged for the play area to be inspected as soon as possible and a piece of defective equipment was repaired immediately. Also, the play area is surrounded by tall trees which inevitably results in a lot of moss and debris building up in the play area. This was also cleared within a week and the surface sprayed. Cllr. A. Pattinson will check the area regularly and inform the VGCBC should further works be required.

Cllr. R. Thomas reported that a section of the road near The Place For Homes is sinking. The Clerk will report this to the VGCBC.

Cllr. R. Thomas reported that there are several large potholes near the double bend on Grove Road. The Clerk will report this to the VGCBC.

APPENDIX 1

Dear Mr Thomas,

Weight Limit and Traffic Measures in Llysworney/Llandow: Condition 14 2014/01505/8CD

Forgive the length of this letter but, in seeking your assistance to resolve this matter, it seemed best to set things out in full. We seek an urgent meeting with you and your planning and highway colleagues to discuss the issues raised.

As you will be fully aware, the problem of the B4268 road through Llysworney (single track sections and bisecting of the village) has long been acknowledged- on grounds of safety, environment and inadequacy of access to commercial sites at Llandow – giving rise to proposals for a Llysworney bypass in the former Vale of Glamorgan UDP. The Council has never had the means to implement a bypass scheme and has looked to the private sector for funding. The planning application (2014/01505/OUT) for new housing at Darren Farm, Cowbridge, incorporating a link road between the A48 and B4270, provided a solution which would enable through traffic to be routed away from Llysworney and the former bypass policy to be omitted from the Local Development Plan.

In the Final Report to the Planning Committee on the application (p43) http://vogonline.planning-register.co.uk/PlaRecord.aspx?AppNo=2014/01505/OUT it was stated that:

"The proposed link road is welcomed due to the benefits it will provide as an alternative route for heavy goods vehicles currently accessing the A48 via Llysworney. The village currently suffers from HGV vehicles through the centre of the village, where there is a pinch point with single file traffic only. The heavy flow of such traffic has a detrimental effect on the environment, local amenity and the free flow of traffic and the link road, whilst not removing all traffic would certainly divert traffic, especially commercial traffic, from passing through the village. The Highway Authority has requested that the developer pays for a Traffic Regulation Order (TROs) in respect of weight restrictions for Llysworney village to ensure heavy vehicles are re-directed to the new link road once operational." (our underlining).

In his Final Highway Comments (Rev B) on behalf of the Highway Authority Mr Mike Clogg http://vogonline.planning-register.co.uk/PlaRecord.aspx?AppNo=2014/01505/OUT requested that:

"Prior to the first beneficial occupation of any of the dwellings or the first operational use of the link road hereby approved, the developer shall carry out the following off-site highway works in accordance with details that shall first be submitted to and approved in writing by the Local Planning Authority:

- a) A signing and lining strategy for the local highway network in the vicinity of the site affected by the proposed development including re-directing traffic away from Llysworney village;
- b) Off-site highway works at Nash junction to include consideration of a change in priorities for vehicle movements at the junction; and
- c) Traffic calming measures near properties known as Penryheol Terrace on Llantwit Major Road." (p3)

"New and amended Traffic Regulation Orders (and any associated road markings and signage) will need to be approved by the Highway Authority and will be subject to the statutory consultation process. The full cost of which will be met by the Developer. TROs are required in respect of the following:

- a) Speed restrictions and new access on Llantwit Major Road;
- b) Changes to speed and new junction onto A48;
- c) Weight limits through Llysworney;
- d) New Puffin Crossing on Llantwit Major Road;
- e) Highway works at Nash Junction; and
- f) Traffic calming near to properties known as Penryheol Terrace on the Llantwit Major Road." (p5)

The above conditions and obligations were approved by the Planning Committee on 14 January 2016 and Taylor Wimpey has provided monies, under Legal Agreement, to meet its obligations under the planning permission. Work on the housing is well advanced and the link road is progressing to completion.

Following more than thirty years of waiting for a solution, when all the while traffic has been increasing, Members of the Community Council and village residents were extremely relieved that conditions in Llysworney would finally be improved. Indeed, in a recent survey conducted by Llysworney Community Association, all respondents cited "a road solution" as the main thing that would enhance life in the village. Accordingly, we are both alarmed and dismayed at the possibility that the Council's commitments might not be fully delivered, as suggested in the attached e mail. This

following multiple requests for information and a promise from Mr Clogg that we would be included in the discussions, and our views would form part of the decision-making process.

Although it is, of course, accepted that new signing will help to re-direct traffic away from the village, the B4268 would still provide the most direct route for Llandow-bound HGVs using Junction 35 of the M4 and for those relying on SatNav (and increasingly drivers of HGVs and others use SatNav rather than following road signs). Omission of the weight limit would not, therefore, disincentivise drivers from using the B4268 in favour of the improved B4270, particularly drivers unfamiliar with the inadequacies of the local road network. The position is exacerbated by the potential lack of road improvements/re-prioritisation at Nash Corner junction – inferred from the lack of any mention of them in Mr Clogg's update. Traffic is only set to increase as developments proceed at Llandow, Llantwit Major and St Athan, in line with planning policy, such that resolution is essential. We are firmly of the mind that if the Council does not deliver on its stated commitment, the opportunity will be forever lost, to the detriment of long-suffering residents.

Whilst we are aware that South Wales Police have formally expressed that they are unable to support a weight limit due to their resources to enforce it, this is not a reason for the Council to renege on its commitment to impose one; police support is not a necessary pre-requisite for the Order. After all, given the current squeeze on police resources, enforcement in all traffic (and other) regulatory areas is compromised (and expectations tempered). This alone is clearly no justification for dropping the Council's weight limit and associated highway improvement proposals. Moreover, the local Police Inspector, Andrew Rice, has affirmed his position that the new road is, indeed, the preferred option for travel and, in a meeting with local residents (see attached e mails), he acknowledged the traffic problem in Llysworney and offered his support.

Thus, the opportunity provided by the new link road to bypass Llysworney, consigning heavy vehicles, once and for all, to a more suitable route, cannot and must not be discarded lightly. The LCC seeks only to hold the Council to account in doing what it said it would do, that is incorporating its own recommended essential measures to re-direct traffic away from the village. We believe that the Council would be failing in its duty should approval of Condition 14 fall short of the commitments in its own planning resolution.

Your highway advisor's e mail indicates that his team are close to "finalising some minor outstanding signing issues with the developer Taylor Wimpey and that "When fully finalised and approved, details of the <u>discharged</u> condition 14 will be available via Council's the planning register and reference 2014/01505/8/CD." (our emphasis). It suggests a done deal.

Currently, drawings on the website under this reference are out-of-date and mutually contradictory (ie the Nash Corner junction drawings show closure of the Llandow village access, the signage drawings show it open – clearly a matter of significant concern to Llandow residents). In the absence of details for a weight limit and improvements at Nash junction conforming to the Planning Committee's decision on the Link Road, we have no option but to strongly object to any such approval in relation to Condition 14. We further observe that any subsequent recommendation for approval in non-conformity with the Planning Committee's resolution, is a matter for Council Members rather than officer delegation.

A matter of such significance for our community cannot be a *fait accompli*. It is an extreme imperative that we have the opportunity to discuss with you how the Council's commitment to prevent HGVs from transitting the village of Llysworney can be achieved. Our constituents will not forgive us if we do not do everything in our power to resolve this continuing problem.

This Council notes the 'Special Report on Global Warming of 1.5°C' Intergovernmental Panel on Climate Change (IPCC)', (October 2018), which found that:

- Human-induced global warming has already caused multiple observed changes in the climate system
 which include more frequent heatwaves in most land regions, an increase in the frequency and duration of
 marine heatwaves and an increase in the frequency, intensity and/or amount of heavy precipitation events at
 the global scale.
- Human activity related global warming reached approximately 1°C above pre-industrial levels in 2017, and is likely to reach 1.5°C between 2030 and 2052.
- A 1.5°C rise will result in multiple negative impacts, including increases in frequency, intensity and/or
 amount of heavy precipitation in several regions, and the majority (70–90%) of warm water (tropical) coral
 reefs that exist today will disappear.
- A further increase to 2°C rise will result in much more severe harm, including a greater risk of water scarcity in some regions and increased frequency of severe weather events, droughts, floods, higher sea level rises, crop failures and destruction of land and marine eco-systems with the loss of 99% of tropical coral reefs.
- With current strategies, the world is on track to overshoot the 1.5°C limit of the UN Framework Convention on Climate Change Paris Agreement before 2050 and exceed 3°C by 2100.
- Limiting global warming to 1.5°C may still be possible with ambitious action from local and national government, organisations and businesses, and local people and their communities.

This Council further notes:

- The commitment of the administration to deliver its Well-being Goals as set out in the Corporate Plan 'Strong Communities with a Bright Future' and the Well-being of Future Generations Act, and the progress of initiatives in support of the existing Carbon Management Plan.
- That bold action to reduce carbon emissions can also deliver benefits in terms of new jobs, economic savings and market opportunities.

This Council therefore resolves to:

- 1. Join with Welsh Government and other councils across the UK in declaring a global 'climate emergency' in response to the findings of the IPCC report.
- 2. Reduce its own carbon emissions to net zero before the Welsh Government target of 2030 and support the implementation of the Welsh Government's new Low Carbon Delivery Plan, to help achieve the Welsh Government's ambition for the public sector in Wales to be carbon neutral.
- 3. Make representations to the Welsh and UK Governments, as appropriate, to provide the necessary powers, resources and technical support to local authorities in Wales to help them successfully meet the 2030 target.
- 4. Continue to work with partners across the region to develop and implement best practice methods that can deliver carbon reductions and help limit global warming.
- 5. Work with local stakeholders including Councillors, residents, young people, businesses, and other relevant parties to develop a strategy in line with a target of net zero emissions by 2030 and explore ways to maximise local benefits of these actions in other sectors such as employment, health, agriculture, transport and the economy.
