141/17. **LLANDOW:**

Cllr. A. Pattinson reported that the new defibrillator had been installed on the wall of the village hall in Llandow.  
Cllr. A. Pattinson reported that the stretch of road at the entrance to the village near Maes-y-Felin, whilst it had  
been patched, was in a very poor state of repair with an uneven surface and a manhole cover sticking up, and  
needs complete resurfacing. This would undoubtedly be more economic overall. Cllr. A. Pattinson agreed to send  
the Clerk a photograph of the area of road which he will then report to the VGCBC.

Cllr. A. Pattinson reported that the large pot hole in the lay-by / pull-in just before the entrance to the village was  
still in need of filling. The Clerk will report this matter to the VGCBC again.

Cllr. T. Phillips reported that the street light near Maes-y-Felin still has not been replaced. Cllr. Phillips and The  
Clerk have reported this repeatedly. Cllr. Phillips had a reference from the Vale Contact Centre of 6886564. The  
Clerk will write to Mr. Clogg (VGCBC) and ask for an update.

**143/17. SIGINGSTONE:**

Cllr. A Clarke reported that a wall at the crossroads, near the grit bin, was collapsing into the highway due to a tree undermining it. Cllr. Clarke agreed to send a photograph of the collapsing wall to the Clerk who would then report the matter to the VGCBC.
