Minutes of a Meeting of the Llandow Community Council held at Llandow Village Hall, Llandow on Thursday 7th November 2019 at 7.30 pm.

94/19. DECLARATIONS OF PECUNIARY INTEREST, ETC:

No declarations of interest were made.

95/19 S&A GROUP PRESENTATION: The Vice Chairman welcomed Mr. James Kerr, Finance Director and Mr. John Lloyd, Llandow Site Manager, from the S&A Group. Mr. Kerr gave an overview of the S&A Group's business activities in the UK and further afield. The company would like to expand their operation at their Llandow site and will be applying for planning permission to build 2.5 hectares of polytunnels. This will enable them to grow between 400 and 450 tons of strawberries per annum at Llandow during the 40-week growing season. This equates to approximately 10% of the current Welsh demand. The polytunnels will be 4.5m high and extra screening will be installed to act as both a visual screen and windbreak. There are currently 14 accommodation pods, out of the 20 for which planning permission has already been granted. It is anticipated that no more than 20 pods will be required to house all the staff required.

A separate application will also be made for the renovation of an existing barn as a training centre for other fruit growers who wish to enter into a franchise arrangement.

An open evening at Llandow Village Hall is planned for residents to examine the plans and ask any questions they may have; this will form part of the pre-application consultation.

Members had the opportunity to ask questions regarding the details of the proposed applications, after which the Vice Chairman thanked Mr. Kerr and Mr. Lloyd for their informative presentation. We await a planning application in due course.

96/19. MINUTES OF THE PREVIOUS MEETINGS:

98/19. MATTERS ARISING:

Darren Farm Development & Weight Limit through Llysworney: It was noted that the formal consultation was underway, after which and depending on the responses received, the Traffic Order will either be made under 'Officer Delegated Powers' or referred to Cabinet for a final decision which it is anticipated will be favourable. It is hoped that the weight restriction and signage strategy will be in place by early spring.

Llandow Village Hall: The Clerk reported that he had received a letter of thanks from the Chair of Llandow Village Hall Committee for the recent grant which Council had awarded.

Collection of green waste: It was reported that there had been multiple difficulties with the collection of green waste in the previous month in all three villages. Several Members had been in contact with the VGCBC to report the problems and had received varying reasons for the problems and revised collection days. Llysworney had not had a collection for five days, but Llandow and Sigingstone residents had experienced a two-week delay before their waste was collected. Members did appreciate that during the roll-out of the new waste collection scheme there may be some difficulties, but the VGCBC certainly needs to become far more responsive if residents are to have any confidence in the new arrangements.

Proposed Consultation – Llysworney

The Vale of Glamorgan Council is set to consult on a proposed 7.5 tonne weight restriction through the village of Llysworney to prevent HGVs travelling through the village.





The new weight restriction, if agreed, will prevent any vehicle that weighs more than 7.5 tonnes from travelling through the village, with an exemption for those needing to gain access to properties or premises. The provision of a new road as part of the Darren farm development in Cowbridge will provide a safe, efficient and practical alternative for traffic wanting to travel to and from the Llandow Business Park area. However, in order to maximise the benefits to the community of Llysworney, it is important that a weight restriction be inposed so that heavy vehicles are actually prohibited from travelling through the village. The restriction will require HGV traffic to join the B4270 at Nash Corner and then re-join the A48 at the new roundabout near to Llanfrynach Drive. A formal legal notice proposing a Traffic Restriction Order will now be published. A statutory consultation period will then follow and it is hoped that the restriction will be in place by the end of the year.
