Minutes of a Meeting of the Llandow Community Council held at Llandow Village Hall, Llandow on Thursday 16th January 2020 at 7.30 pm.

- **2/20. APOLOGIES:** Mr. A. Cave, Mr. R. Finucane and PCSO A. Stone.

3/20. DECLARATIONS OF PECUNIARY INTEREST, ETC:

No declarations of interest were made.

4/20. MINUTES OF THE PREVIOUS MEETINGS:

It was agreed to accept the minutes of the meeting held on 5th December 2019.

Proposed by Cllr. C. Bray, seconded by Cllr. A. Clarke.

5/20. POLICE REPORT:

PCSO Stone conveyed (by email) that one crime had been reported in the preceding month; theft of a vehicle from the Llandow area.

6/20. MATTERS ARISING:

Darren Farm Development & Weight Limit through Llysworney: The Clerk reported that a letter had been received from Mr. Mark Simpson, (VGCBC, Operational Manager, Engineering) which confirmed that Cabinet, at its meeting of the 16th December 2019, had recommended that the 7.5 tonne weight restriction be implemented through Llysworney Village. The relevant notices would now be placed in the press and it is anticipated that the Traffic Order would be sealed by the end of January and the signage installed.

Cllr. C. Cave reported that she had spoken with the Officers concerned with the restructuring of Nash junction which will become essential once the weight limit is in place. They assured her that matters are being taken forward in that regard.

Water running off field at East View: Cllr. C. Cave reported the problem to Mr. M. Clogg and he had responded by commenting that Llandow does flood regularly. Cllr. Cave informed Mr. Clogg that she is well aware of the ongoing issues with flooding in the village, however, this is a wholly different and new issue and reiterated her concern regarding the damage to the road which is deteriorating rapidly. Mr Clogg has now agreed to investigate the matter and we await further information in due course.

Potholes at Splott Cross: Cllr. R. Thomas reported that the large potholes at Splott Cross have been attended to. *Road near the Place for Homes:* Cllr. R. Thomas reported that the road is still sinking near 'The Place for Homes'. The Clerk will report this matter again to the VGCBC.

Car causing an obstruction at Llandow: It was reported that the car that was regularly causing an obstruction seems to have stopped parking in that particular place.

Potholes near The Old Rectory, Llandow: Cllr. A. Pattinson reported that there are still two large potholes near the Old Rectory, Llandow. The Clerk will report this matter again to the VGCBC.

Road between Rectory Farm and Llanmihangel Cross: Cllr. A. Clarke reported that the road between Rectory Farm and Llanmihangel Cross is being undermined by the brook. The Clerk will report this matter again to the VGCBC.

Potholes between Moors Head and Penyrheol Terrace: Cllr. A. Clarke reported that there are several large potholes near the bridge over the brook, on the road between Penyrheol Terrace and Moorshead Farm. The Clerk will report this matter again to the VGCBC.

The discussion had centred on the reduction of air traffic control beacons in the UK from 45 to 19 and how Cardiff International Airport would be served in the future.

13/20. LLANDOW:

- Cllr. A. Pattinson reported that there are three large potholes at the side of the road near Nash junction on the road to Llandow. The Clerk will report this matter to the VGCBC.
- Cllr A. Newman reported that there had been two instances of cats being shot with an air rifle. All agreed this was very worrying. The matter had been reported to the Police and an investigation is underway.
- Cllr. R. Thomas reported that there had been several floods near Gluepot Bridge. He has reported the matter to Network Rail and the VGCBC.
- Cllr. C. Cave reported that there has been an increase in dog fouling in the area around East View and Grove Road. Cllr. A. Pattinson reported that she has penalty notices from the VGCBC which she will hand on to Cllr. C. Cave to display as required.

14/20. LLYSWORNEY:

There were no items to report.

15/20. SIGINGSTONE:

Cllr. A. Clarke reported that there is a large pothole in the middle of the West Lane leading from Sigingstone towards the karting track.

Cllr. A. Clarke reported that there is a timber clad static caravan in the garden of Green Meadow, Sigingstone. It had been assumed it was being used by the occupants of Green Meadow whilst they renovated the property, however, it now appears this accommodation is being advertised on Air B&B. The Clerk will report this matter to the VGCBC.

16/20. COUNCIL DECISIONS:

Council noted the report of Cllr. C. Cave (Appendix 2).

Civic Amenity Site: Cllr. R. Thomas asked for an update in regard of the civic amenity site at Llandow following recent speculation that had been conveyed to him. Cllr. C. Cave reported that it is anticipated that the VGCBC will ask for an extension to the existing lease until such time they can identify a more suitable site in the west of the county.

17/19. OTHER BUSINESS:

Congestion Charges in Cardiff City Centre: Council noted the ongoing discussions regarding the possibility of introducing a congestion charge in Cardiff City Centre. Cllr. C. Cave reported that the VGCBC are opposed to this and have written to Cardiff County Council to inform them of them same.
