Darren Farm Development, Weight Limit through Llysworney, Traffic Calming at Penyrheol Terrace & Re-alignment of Nash Junction: Cllr. J. 204/21. PLANNING:

Applications:

1.) **Glebe Field Barn, Llandow**: Two storey extension and entrance porch to existing converted barn dwelling, conversion of existing adjoining single storey barn and construction of a garage on the site of a previous barn. *Concern was expressed regarding the proximity of the prosed development to a public right of way. It was agreed the Clerk would make this observation to the Planning Authority.*

Approvals:

- **1.) Springfield Nursery, Sutton Road, Llandow**: Installation of a 400 cubic capacity water tank (production of heat for use in the existing polytunnels and CO₂ production).
- 2.) Jordan Civil Ltd, Tumulus Way, Vale Business Park, Cowbridge: Erection of an industrial building comprising 2.no Class B8 units.

205/21. LLANDOW:

Potholes: Cllr. A. Pattinson reported that a number of potholes in and around the village have been identified and marked with yellow paint. It is hoped they will be repaired soon.

Bridge to the Village Hall: Cllr. A. Pattinson reported that the bridge to the village hall had been damaged. Cllr. C. Cave agreed to report this to the VGCBC.

206/21. LLYSWORNEY:

Potholes: It was noted that, as in Llandow, a lot of potholes have been identified and marked with yellow paint.

207/21. SIGINGSTONE:

Pollution in the brook: Cllr. A. Clarke reported that from time to time the brook becomes cloudy. After some discussion it was felt it would be best to monitor the situation in the first instance.

Recycling Centre: Cllr. C. Cave reported that the new recycling centre will be located near Travis Perkins on Llandow Industrial Estate.

Llandow Industrial Estate potholes: Cllr. C. Cave had reported the potholes near the karting track and all agreed that section of road needs to be re-surfaced. Cllr. Cave agreed to make that suggestion to the VGCBC.
